

## **Regulations of Camping de la Vée**

### **Article 1:**

The regulation will apply to all person allowed to camp on the campsite.

The car-park located in front of the campsite is exclusively reserved for the campsite.

It is allowed to park on this car-park:

- Before check-in
- In case of a late arrival after opening hours of the Reception
- For campers wishing to leave before or after opening hours of the gate

### **Article 2:**

No one is allowed to camp without the manager agreement.

### **Article 3:**

This is a 3 stars campsite.

Please find the price list in the Reception and on bulletin boards. All rates have to be paid for the entire stay. There is no discount in case of absence.

Campers who want to leave before 9 A.M. have to pay the day before departure prior 6 P.M..

### **Article 4:**

The day of the arrival, campers have to register to the Reception and read the regulation. They will have to present their identity cards.

The Manager will decide for a pitch, according to the wishes of the campers and will register their stay.

Campers are not allowed to take a pitch without the agreement of the Manager.

### **Article 5:**

A pitch is maximum for 6 person.

#### Article 6:

The Director of the campsite represents the Owner of the Campsite. He notices the negligence in the regulation. He is authorized to collect fees by order of March 4<sup>th</sup> of 2016 establishing him manager holder of the state central over recipes. He takes any useful measure for the maintenance of law and order, the cleanliness and the good behavior of the campsite.

#### Article 7:

A proper clothing is required.

No word, song or attitude may shock the neighborhood especially children.

Are forbidden on the campsite: any political meeting, religious meeting or any commercial propaganda.

The use of the radio or any else sound instrument is tolerated as for as it does not disturb the neighborhood.

Violent games are forbidden.

Total silence is rigorous between 10 P.M. and 7 A.M. but from 9 P.M. and before 8 A.M., any noise, glass dump, sound or call must be avoided.

#### Article 8:

Visitors are under responsibility of the campers who welcome them. Visitors must come and register to the Reception when they arrive. A fee per visitor will have to be paid. No visitor allowed after 8 P.M.. Visitors have to park their vehicle out of the campsite on the car-park.

#### Article 9:

Sorted out waste must be collected in closed plastic bags and put in the corresponding recycling container.

Sanitary block (showers and toilets) are strictly for Camping de la Vée's campers and also for the persons authorized by the Director of the campsite, with an invoice.

It is asked to the campers to let the toilet, basin, shower, clothes basin and dish basin as cleaned as they would like to find it.

It is forbidden to throw away waste-water or chemical toilets on the floor or in the water-tap: there are special places to empty the buckets.

It is forbidden to wash vehicles on the campsite or connect with the hydrants.

Article 10: Safety:

Open fire are prohibited.

Find a "first aid emergency case" at the Reception.

An emergency bell to call the Manager is located at the entrance of the Reception.

Electric wires and cables must be in good conditions and well visible.

Article 11:

Drive and park in the campsite by respecting the road marking and the speed.

Maximum speed is 10 km / hour on the campsite.

Commercial, wishing to sell their commercial proposal will need the agreement of the Director of the campsite.

Except maintenance vehicles, commercial vehicles are forbidden on the campsite.

The entrance gate is closed from 10 P.M. to 6 A.M..

Between 10 P.M. to 6 A.M, it is forbidden to drive with any vehicle with a motor.

Every camper walking at night in the campsite must be careful not to disturb the other campers asleep.

Article 12:

It is forbidden:

- To plant nails in trees
- Cut branches
- Burn wood fire: please be vigilant when using a gas stove or barbecue. Any degradation will be charged.
- To limit yourself your pitch.
- To dig holes or ditching of drains.

Any degradation to the ground, the vegetation, fences or shared facility places will engage the responsibility of the author of the action with Régie Camping de la Vée.

Any corporal or material accident done by a camper must be immediately related to the Manager of the Campsite.

Article 13:

The motorhomes must park the 4 wheels on the hard-standing place.

Article 14:

Any animal will be accepted in the campsite as soon as they are kept on a lead. For each animal, we will ask for a pet passport. The animal must not bark or defecate in the campsite. Plastic bags to collect poop are on disposal at the Reception.

The responsibility of the owner will be engaged for any trouble.

The animals are not allowed in the sanitary blocks, the meeting room or shared facility places.

Article 15:

And besides the punishment provided by the law, any infringement to this regulation will lay to those sanctions:

- Reminder
- Temporary exclusion
- Definitive exclusion
- Record of disciplinary proceedings either by the Director of the campsite or the officer of the police
- Payment of a fine regarding to a rate approved by the Mayor of the city

Article 16:

The National Constabulary, the local agent of the Police Force and the Director of the campsite are in charge for their part to apply this regulation which is displayed on the board.
